Appointment of the new Chair of the Cwm Taf

Learning and Improvement Framework

The Safeguarding Board's Learning and Improvement Framework demonstrates how learning will be identified, disseminated and implemented in practice in order to improve outcomes for children, young people and adults within Cwm Taf Morgannwg.

The Framework recognises that Board partner agencies have their own internal governance and learning structures and therefore, seeks to complement and build on current single agency arrangements by adding a multi-agency approach to support partner agencies to learn lessons from a range of functions and reviews and to use this learning to improve joint working.

Section 128 of the 2014 Act requires a 'relevant partner' of a local authority (as defined in section 162) to inform the authority if they suspect a person in its area is an adult at risk (or if the person is in the area of another local authority, to inform that other authority). It also requires a local authority to inform another local authority (in Wales or in England) if an adult they suspect to be at risk is living or moving to the area of that other authority.

Section 130 of the 2014 Act requires a 'relevant partner' of a local authority (a youth offending team for any area of which falls within the area of the local authority or a relevant partner as defined in section 162) to inform the authority if they suspect that a child in its area is a child at risk (or if the child is in the area of another local authority, to inform that other authority).



When to contact the police

If there are immediate concerns about the adult's safety or a criminal offence against an adult at risk has occurred, they should contact the police without delay to protect the adult from the risk of imminent danger.

Examples of possible crimes include: alleged sexual assault, alleged physical injury, allegations of theft, threats and aggressive behaviour by a suspected perpetrator. Human trafficking, honour killings, female genital mutilation (FGM).

All the above would indicate that there is a duty to make a report.

If in doubt as to whether an offence has occurred, seek advice from the police.

A child at risk is one who is experiencing or is at risk of abuse, neglect or other kinds of harm, and has care and support needs. Section 130 also requires a local authority to inform another local authority (in Wales or in England) if a child they suspect to be at risk is living or moving to the area of that other authority.

Practice Reviews

Regional Safeguarding Boards have a statutory responsibility to carry out a practice review in cases where a child, young person or adult at risk has:

- died
- sustained potentially life threatening injury; or
- sustained serious and permanent impairment of health.

The purpose of a review is to identify learning for future practice. It involves practitioners, managers and senior officers exploring the detail and context of agencies' work with an individual and family. The output of a review is intended to generate professional and organisational learning and promote improvement in future inter-agency adult protection practice.

Preventing and Tackling Child Abuse and Exploitation

An e-bulletin has been produced which contains information and a range of resources which were developed as part of the implementation of the Welsh Government's **National Action Plan on Preventing and Tackling Child Abuse**.

A toolkit has been prepared which aims to turn the principles in the All Wales Protocol: reducing the criminalisation of care experienced children and young adults. Practice reminder - Professional responsibilities to absent parents

The publication of a recent child practice review highlighted the requirement for all practitioners working with families to be reminded of their responsibilities to parents who are not actively involved in their child's life.

When working with the family and child, all attempts to ascertain their whereabouts and consider how we are to include them must be recorded.

Not having parental responsibility must not be used as an automatic reason to exclude and in cases where for instance a father doesn't have parental responsibility but there is no dispute about paternity, it should be explored what part they could play in the child's life and the child protection process.

March 2023 marked the one-year anniversary of the 'Ending Physical Punishment in Wales' law coming into force, with a communications campaign, including TV and radio adverts, that were broadcast in February.
